RAMP is a non-profit, nonresidential Center for Independent Living (CIL) that emulates the Independent Living Philosophy with a mission to build an inclusive community that encourages individuals with disabilities to reach their full potential. RAMP is the only Center for Independent Living that serves Boone, DeKalb, Stephenson, and Winnebago Counties as well as the only agency providing advocacy AND independent living services for persons with disabilities. We provide five core services: Information & Referral, Education & Advocacy, Peer Support, Independent Living Skills Training, and Transition Services. More than 51% of our staff and board have a disability. As part of our services, we provide training for organizations and people with regard to any disability needs they may have.



Training Descriptions

Ableism:

Defining, identifying, understanding, and eradicating discrimination against disability, known as ableism

Disability Awareness:

General information, etiquette, accessibility, and language usage surrounding disability

Inclusive Work Environment for Disabled Employees:

What constitutes disability, what are accommodations and why are they provided, how to implement workplace inclusion

Independent Living Philosophy:

Historical treatment of and events, awareness and etiquette, and advocacy regarding disabled persons and independent living

Microaggressions in the Workplace:

Definition and effects of microaggressions, scenarios/role play, and eliminating microaggressions in the workplace

Poverty Response:

Scarcity mindset, trauma of poverty, roots of poverty, and long-lasting effects on children & adults

Service Animal Awareness:

Definition, certification, breeds, and general rules surrounding service animal use

Disability Awareness for the Judicial System:

Disability awareness for judges and court personnel, focusing on ADA requirements, legal equality, and reasonable accommodations

Talking to Children About Their Disability:

Training for parents and educators in assisting children and their siblings in understanding their disability as well as advocating in your community for disability inclusion

Disability Awareness & Inclusion for Childcare

Workers: Training for childcare workers with children from infancy to age 12 in creating an inclusive environment for all children, including those with disabilities

Accessible Social Media:

Creating social media materials that are accessible for all, including closed captions, image descriptions, art design, and more

Disability Awareness for Public Safety Personnel:

Disability awareness for various public safety personnel focusing on ADA requirements, positive interactions, and reasonable accommodations

Intellectual & Developmental Disabilities: Healthy Relationships & Assault Awareness: A two-track training that provides awareness on healthy relationships and response to sexual assault for those with intellectual/developmental disabilities and for educators/care providers who assist them
